The duly organized Grand Jury of Harris County, Texas, presents in the District Court of Harris County, Texas, that in Harris County, Texas, GREGORY F. JABLONSKI, hereafter styled the Defendant, heretofore on or about VARIOUS DATES BETWEEN NOVEMBER 1, 2006 AND FEBRUARY 13, 2009, did then and there unlawfully, engage in fraud in connection with the offer for sale and sale of National Life Settlements, LLC, Note Agreement-A-1," promising to pay 8% to 10% per annum return for five (5) years and/or National Life Settlements, LLC, Notes and Fixed Income Agreements, often referred to as the "I' plan," promising a fixed rate of return of 8% to 10% with 130 periodic payments made for five years and the full return of the principle amount invested after five (5) years, being securities, to wit: notes, evidences of indebtedness and investment contracts, to one or more of the below named persons, hereinafter called Complainants, by:

- Intentionally failing to disclose that the Defendant, was also a principal of My E-Networks, Inc., a company that filed for bankruptcy
  on or about June 20, 2007 with almost \$6 million in liabilities and \$57,652.00 reported as assets, said information being a material
  fact;
- 2. Intentionally failing to disclose that on or about January 29, 1998, Howard Judah, a principal of National Life Settlements, LLC, was convicted of Conspiracy to Commit Wire Fraud in <u>United States of America v. Howard Glenn Judah</u>, Case Number 1:97CR00051-001, in the United States District Court for the Southern District of New York, and he was thereafter sentenced to serve thirty-two months in the United States Bureau of Prisons and ordered to serve three years of supervised release upon release from incarceration, and to pay \$3,552,000.00 in restitution; said information being a material fact;
- 3. Intentionally failing to disclose that, in connection with Howard Judah's conviction of Conspiracy to Commit Wire Fraud in United States of America v. Howard Glenn Judah, Case Number 1:97CR00051-001, in the United States District Court for the Southern District of New York, Howard Judah and his co-conspirator were convicted of devising a scheme to sell to victims non-existent or fraudulent bank documents referred to as "prime bank guarantees" by (a) promising extraordinarily high rates of return with little or no risk and (b) telling victims of the scheme that he was a senior executive of Ford Motor Credit and/or Ford Motor Company at a time when Howard Judah knew that he was never a senior executive of Ford Motor Credit and/or Ford Motor Company and (c) telling victims of the scheme that they would earn millions of dollars by investing \$150,000 when he well knew they would not earn millions of dollars from such an investment and (c) using investor funds from the scheme to repay victims of a scheme under investigation by the Harris County District Attorney's Office, said information being a material fact;
- 4. Intentionally failing to disclose that restitution in the amount \$3,552,000.00 ordered to be repaid by Howard Judah, in connection with Judah's conviction for Conspiracy to Commit Wire Fraud in <u>United States of America v. Howard Glenn Judah</u>, Case Number 1:97CR00051-001, in the United States District Court for the Southern District of New York had not been paid, said information being a material fact;
- 5. Intentionally failing to disclose that on or about May 23, 1997, Howard Judah, a principal of National Life Settlements, LLC, was convicted of Engaging in Monetary Transactions In Property Derived from Specified Unlawful Activity in <u>United States of America v. Howard Judah</u>, Case Number 1:94CR00448-0001, in the United States District Court for the Southern District of New York, and he was thereafter sentenced to serve forty-six months in the United States Bureau of Prisons and ordered to serve two years of supervised release upon release from incarceration, said information being a material fact;
- 6. Intentionally failing to disclose that, in connection with the Howard Judah's conviction for Engaging in Monetary Transactions In Property Derived from Specified Unlawful Activity in <u>United States of America v. Howard Judah</u>, Case Number 1:94CR00448-0001, in the United States District Court for the Southern District of New York, Howard Judah was convicted of combining and conspiring with others to transfer funds that were purportedly the proceeds of cocaine sales from the United States through an account in France to an account in Montevideo, Uruguay, said information being a material fact;

- 7. Intentionally failing to disclose that on or about July 15, 1996, Howard Judah, a principal of National Life Settlements, LLC, was convicted of Contempt of Court in <u>United States of America v. Howard Glenn Judah</u>, Case Number 1:95CR00815-001, in the United States District Court for the Southern District of New York, and he was thereafter sentenced to serve twelve months and one day in the United States Bureau of Prisons, ordered to serve three years supervised release upon release from incarceration, and ordered not to make any financial transactions without consent from the Probation Department while serving supervised release, said information being a material fact;
- 8. Knowingly misrepresenting that Warren Buffet was an investor, owner or affiliated with National Life Settlements, LLC, and that National Life Settlements, LLC was the custodian of policies on behalf of a company controlled by Warren Buffet known as GenRe, the said information being a relevant fact;
- 9. Knowingly misrepresenting that National Life Settlements, LLC, was one of the largest providers of life settlements in the nation, the said information being a relevant fact;
- 10. Knowingly misrepresenting that National Life Settlements, LLC, had received billions of dollars from the Federal Reserve and/or the United States Government, the said information being a relevant fact;
- 11. Knowingly misrepresenting that National Life Settlements, LLC, often bought large groups of life insurance policies and/or had a huge number of life insurance policies and acquired ten to fifteen policies per week, the said information being a relevant fact;
- 12. Intentionally failing to disclose that, from November 1, 2006, until January 1, 2008, National Life Settlements, LLC, received over \$2,800,000 from investors who purchased said securities but National Life Settlements, LLC did not acquire any interests in any life insurance policies to secure said securities, said information being a material fact;
- 13. Intentionally failing to disclose that, from January 1, 2008, through February 13, 2009, National Life Settlements, LLC, only acquired indirect interests in three life insurance policies to secure the said securities, that these indirect interests related to three life insurance policies with a predicted maturity exceeding the fixed maturity date of said securities, and that one or more of these life insurance policies was in the contestability period and thus subject to cancellation by the issuing insurance company, the said information being a material fact;
- 14. Intentionally failing to disclose that National Life Settlements, LLC, never became the legal owner or direct beneficiary of any life insurance policies that would secure said securities, said information being a material fact;
- 15. Intentionally failing to disclose that funds tendered by investors were transferred to family members and other entities controlled by the Defendant and Howard Judah and used for personal purposes, such as the purchase of houses and automobiles, the said information being material fact;
- 16. Intentionally failing to disclose that the Defendant and Howard Judah were transferring funds tendered by investors for the purchase of said securities and using said funds for purposes unrelated to said securities, the acquisition of life insurance policies or the business of National Life Settlements, LLC, the said information being a material fact;
- 17. Intentionally failing to disclose the true assets and liabilities of National Life Settlements, LLC, said information being a material fact.
- 18. Knowingly misrepresenting that an investment with National Life Settlements, LLC, was guaranteed, the said information being a relevant fact; and/or
- 19. Knowingly misrepresenting that the securities sold herein would be collateralized by life insurance policies, the said information being a relevant fact;

and the amounts obtained for the sale of the said securities were obtained under one scheme and continuing course of conduct and the aggregate amount obtained was \$100,000 or more.




